Various attendees spoke on this issue;

Overall it was decided that for the size of the village, 1 unit was probably sufficient. However it was apparent that there was little knowledge on how the system works. i.e.

IF required, dial 999: The operator will advise the location of the defibrillator and the code required for access to the cabinet if they believe it is required.

Guidance will always be given by the emergence services.

It was determined that the main requirement was to make people aware of the existence on the unit and the protocol for use.

2 Cherry trees and 1 fir tree in poor condition for possible removal. SSPM to have quotes for rectification of tree issue. DD

Old shelter is dangerous and collapsing. To demolish and replace with open bench area and pruning of surrounding trees. SSPC – DC to investigate demolition and DD to have quotes for rectification of tree issue.

Water tap covering in poor order. To be renewed / repaired. SSPC - DD to investigate.
